

Presidents Report



S Mckelvie Tahr Ballot 2019

For those of you who don't know me I'm Shaun Mckelvie "Pinky" I've been part of the NZDA for a while now. I am a keen Thar, Chamois, deer and duck hunter have been since I was big enough to hold a gun. I have 3 daughters that are getting out an about with me now and am enjoying teaching or trying to teach them how to hunt. Although we haven't shot an animal yet its defiantly been an enjoyable challenge getting them out and about with me.

Hopefully you have all been receiving the emails from national NZDA there's been a lot of info coming in with updates from colfo and updates on rule changes and the proposed buy back scheme? And the membership issues that are being worked in case anyone hasn't seen it here is a letter from Rob Howey explaining where they are at .

Email from Rob Howey regarding membership issues

I am going to start by apologizing for the current state of the membership system. I know branches are getting concerned about the accuracy of the new system.

We have been struggling with the new system. Some of this is getting to understand how it works which has slowed down the normal processes in the office, but compounding this is the integration issues between our accounting system and the new membership system (Bitrix). The integration was supposed to be automated but unfortunately there is a bug in the interface which means the Membership records are not being automatically updated when paid.

What are we doing about it:

We have been working closely with our vendor to diagnose and understand the root cause of the issues.

We have also hired a temp to help with the backlog of work in the office.

Once we get all the invoice reconciliations up to date in XERO (our Accounting system) we will then cross reference each invoice to the membership system manually to ensure the accuracy of the data and financial status of the membership records.

This process may take several weeks for us to complete but it will mean that we will have confidence that the financial status of members is correct and that the branch clearing payments are correct.

If there is any question regarding a member's financial status we can resolve it fairly quickly by confirming the bank payment has been received. Membership will be honored from the date of payment.

If any branch is short of cash in the interim please contact me directly and we can arrange for an interim payment based on what we currently know and sort out the balance once the full reconciliation process is complete.

I can assure you that this situation will not re-occur next year as all the bugs will have been sorted out well in advance of the next renewal period.
